# 1. <u>About</u>

1.1 Liverpool Old Hebrew Congregation ['LOHC'] is a registered charity [No. 1089175].

1.2 LOHC's Synagogue is a Grade 1 listed building which opened in 1874

1.3 LOHC organises public events.

# 2. LOHC Website

2.1 The LOHC website is provided for information purposes only. It is for personal and non-commercial use. LOHC cannot promise that the LOHC website will be fit or suitable for any purpose. LOHC does not promise that the LOHC website will be available at all times or that use of the LOHC website will be uninterrupted.

2.2 The intellectual property rights in the LOHC website and in any text, images, video, audio or other multimedia content, software or other information or material submitted to or accessible from the website are owned by LOHC and LOHC's licensors. LOHC and LOHC licensors reserve all intellectual property rights (including, but not limited to, all copyright, trade marks, domain names, design rights, database rights, patents and all other intellectual property rights of any kind) whether registered or unregistered anywhere in the world.

### 3. Events and Tickets

3.1 LOHC issues tickets on its own behalf and, also, may do so on behalf of other promoters and organisers to those wishing to attend events ['attendees']

3.2 Attendees with access or other reasonable adjustment needs should advise LOHC of such at the earliest opportunity.

3.3 Tickets are non-refundable and LOHC reserves the right to change timings/the programme/artists, performers and presenters without notice.

3.4 Booking fees (commission) are, also, non-refundable.

3.5 Tickets are not transferable and may not be resold.

3.6 The venue layout is not always known and LOHC cannot guarantee that there will not be a restricted view.

3.7 It is the responsibility of the attendee to check event details prior to travelling as these may be subject to change.

3.8 LOHC reserves the right to refuse admission in all reasonable circumstances, including for example where LOHC consider an attendee's behaviour may affect others enjoyment of the event

3.9 LOHC reserves the right to eject an attendee from an event in all reasonable circumstances, including for example where LOHC consider an attendee's behaviour may affect others enjoyment of the event.

3.10 Latecomers might not be admitted to an event or may only be admitted at a suitable break in the event

3.11 If an attendee experiences any problems with their seating or enjoyment prior to or during the event, the customer must inform venue staff immediately.

3.12 Smoking, including e-cigarettes, is not permitted anywhere at event venues.

3.13 The unauthorised use of cameras or recording equipment is not permitted. Attendees are not permitted to film or record events. LOHC may be filming/recording events and by attending any event attendees are deemed to agree to be photographed /recorded with LOHC being permitted to use such material for its own legitimate purposes without requiring any consent from any attendee who waive all rights to any claims for payment or royalties in connection with the possible use of their photographs/recordings

3.14 Security measures may be in place for events. Bags may be subject to checks. Attendees should ensure early arrival and avoid bringing large bags. Photographic ID such as a driving licence or passport should be brought to enable verification of the attendee.

3.15 Mobile phones must be switched off during events.

3.16 Attendees attend events at their own risk and should note that loud music noise, lighting and other special effects may impact on them.

3.17 Where an event is cancelled or rescheduled to another date, LOHC will use reasonable methods to notify attendees, but LOHC cannot guarantee that it will be able to get in touch with all attendees. Attendees should check before travelling that an event has not been cancelled or rescheduled.

3.18 Attendees may not bring into the event venue any restricted and illegal items, The prohibited items (non-exhaustive) include alcohol; items of a pyrotechnic nature; signs/banners; illegal drugs; and aerosols. Any such items may be confiscated.

3.19 Additional terms and conditions may be in place for selected events.

#### 4. <u>Code of behaviour for attending events at Princes Road Synagogue</u>

4.1 Princes Road Synagogue is a sacred place and, as such, should be treated with respect in matters relating to behaviour.

4.2 <u>Dress</u>: Please be kind enough to dress appropriately when visiting the Synagogue.

4.3 Please do not bring food or drink onto the Synagogue premises. Refreshments may be provided by the Synagogue for consumption in designated areas.

#### 5. Liability

5.1 All property brought to an event is at the own risk of the attendee and LOHC shall not in any way be responsible for any theft, loss or other damage in respect of such property.

5.2 LOHC nor any other Event Promoter will be responsible for any loss or, damage, death or injury howsoever caused (other than death or personal injury resulting from the negligence of LOHC or any other Event Promoter) unless LOHC, or any other Event Promoter as the case may be, has breached its legal obligations and such loss or damage is a direct and reasonably foreseeable result of such breach.

5.3 Personal arrangements including travel, accommodation or hospitality relating to an event which have been arranged are at the participant's own risk.

#### 6. Collecting and use of Personal Information

6.1 LOHC collects personal information which you give to LOHC (such as the information you supply to LOHC in connection with events organised by LOHC and donations)

6.2 LOHC may use images and recordings in photography/video at LOHC events, which may be held in LOHC archives and/or posted on LOHC website and social media and used by LOHC in furtherance of its objectives

6.3 LOHC may need to disclose your details to third parties including (1) for events in conjunction with another organisation (2) in order to comply with any legal obligations (e.g. the police, regulatory bodies and crime protection agencies); (3) for legal and funding purposes including regulatory or inspection compliance; and (4) service providers acting on LOHC's behalf, in delivering events
